Overview

To lead the leadership and church awareness of the need to safeguard adults with additional care & support needs and children.

To be responsible for implementing the church's safeguarding policy and responding appropriately to concerns as well as supporting the lead recruiter in managing Safe Recruitment of staff and volunteers

Reporting to the Senior Leaders, this role is an incredibly important opportunity to ensure that Revive Church is a safe place for everyone in our church family and the wider community. We will work with the successful candidate to establish meaningful targets, but the key roles and responsibilities are as follows:

- The preparation and implementation of a safeguarding policy and its review annually.
- Ensuring safeguarding policies and procedures are known and followed by leadership, staff, volunteers & church.
- Acting as an advocate on behalf of children and adults in need of protection.
- Arranging and making sure workers and leaders attend relevant training e.g induction, refresher etc
- Keeping accurate records relating to safeguarding concerns in accordance with Data **Protection Guidelines**
- Regularly informing the Leadership on good practice issues eg reports to Trustees
- Working in partnership with statutory and other agencies e.g. Charity Commission, Disclosure & Barring Service, CCPAS
- Act independently in reporting concerns of abuse to the statutory authorities, including Local Authority Designated Officer, Children's or Adult Social Care (formerly Social Services) or the Police.
